Do You Know?

About abuse...

- Nearly 5 Million cases of elder abuse occur each year, but 85% go unreported.(1)
- 15,000 to 19,000 people with developmental disabilities are raped each year in the U.S., (Sobsey, 1994)
- Abused elders have a 300% higher risk of death when compared to those not mistreated.(1)
- Family, friends, caregivers and neighbors are the culprits in financial abuse cases more than half the time.(1)
- More than 90% of people with developmental disabilities will experience sexual abuse at some point in their lives. 49% will experience 10 or more abusive incidents, (Valenti-Hein & Schwartz, 1995)
- By 2030, the numbers of older Americans over age 85 – those most at risk for abuse – will more than double.(1)
